I, _____, understand and agree to abide by the terms listed below for the Electronic Monitoring Program:

1. I will not tamper with the electronic monitoring equipment in any manner.
2. I will be at home during the curfew hours set by my Probation Officer. *(I will not leave early or arrive home late except upon the direction of the Probation Department.)*
3. I will submit my work schedule on a weekly basis. Should I need to change my schedule, I must obtain approval. Deviation from this schedule is considered a violation.
4. I will stay at my residence at all times unless the Probation Department directs that I am allowed to leave.
5. I will maintain electrical service at my place of residence.
6. I will not attempt to remove, damage, disconnect, or tamper with the transmitter placed on my ankle and/or the power cord I am provided.
7. **I am financially responsibly for the care of the equipment issued to me. I will be held financially responsible for any malicious damage to the equipment and be criminally prosecuted for equipment theft. I must return all equipment to the Probation Department upon program completion.**
8. I will allow the Probation Department to inspect the equipment upon request. I will immediately contact the Probation Officer to report any known malfunctions in the monitoring equipment.
9. I understand that I am provided with a power cord. I understand that I must charge the unit for two hours once every 24 hours.
10. The ankle bracelet is water-resistant, **NOT WATER PROOF. DO NOT SUBMERGE IN WATER!**
11. I will immediately contact the Probation Officer if any emergency occurs. An emergency is imminent danger to ones self, family, or household residents, or personal medical needs requiring immediate hospital treatment.
12. I will respond to any telephone calls on my ankle bracelet, my cell phone, or at my place of residence.
13. I will not use or possess any controlled substance or alcohol or enter the premises of any bar or tavern.

14. I will not use or possess any weapons or dangerous ordinances.
15. I agree upon request of the Probation Department to submit breath, blood, and/or urine samples for the purpose of testing for drugs and/or alcohol. **Refusal to submit a sample or any test that registers positive will be a violation of the electronic monitoring program.**
16. I understand that I will not be released from the electronic monitoring program until I have paid for the program in full. Everyday that I haven't paid , I will pay _____ per day extra. **(If applicable)**
17. **I will be subject to arrest for a confirmed electronic monitoring violation.**

The rules of the electronic monitoring program have been provided to me. I fully understand what is expected of me and the possible consequences of any failure to comply with these rules. I agree to release the Sandusky Municipal Court, its personnel and the vendor from any liability associated with my participation in the electronic monitoring program.
